Following points may be considered:-

1. Previously before ERP, So may DDOs under CTD are working. As per Profession Tax Registration details in P.TAX Portal- 21 P.TAX registration found that means approx 20 DDOs are working and all are working independently.
2. On implementation of ERP- all the functions of TDS deduction, payment and Form16 etc have been centralised at circle level.
3. The issue in application related to FY 2008-09 (AY 2009-10) regarding short deposit of TDS to Government authority.
4. No data prior to ERP is available with CSC, TDS Cell ,[8 Hare street](#).
5. The DDO Kalyani has no existence and it has been moved to ALTTC Gaziabad in the year 2022.
6. It is obvious that files and records have been handed over to Administration of CTD consequent upon Circle change of RTTC Kalyani in the year of 2022 or thereafter.

As there is no data in TDS Cell, CSC is unable to comment on this issue, please.

Keeping in view, the case may be reviewed accordingly.
