Please find enclosed the Letter No. AIBSNLREA/CHQ/2024/13 dated 19-2-2024 from Shri RR Balasubramanian , General Secretary of All India BSNL Retired Executives Association addressed to The Director(HR) BSNL Corporate office with copy to CGM Karnataka Circle.(Copy enclosed) on the above subject.

2. The AIBSNLREA has stated in para 3 of their letter that interest shall be payable on retirement gratuity and arrears of pension if any, from the date following the date of expiry of a period of three months from the date of retirement up to the date of payment of arrears of pension and gratuity as per Rule 65(5)(c) of CCS Pension Rules 2021 in respect of a Government Servant to whom provisional pension was paid and retirement gratuity was not paid on retirement in accordance with clause (C) of sub-rule (4) of Rule 8 on account of departmental or judicial proceedings pending against him on the date of retirement and who is **exonerated** of all charges on conclusion of such departmental or judicial proceedings.

3. Para 5 of the letter of AIBSNLREA has mentioned that when the Association took up the matter with DoT New Delhi, it was replied that the VC of the retired executive was received on 19-10-2020 and gratuity was paid on 22-10-2020 and therefore delay has not occurred on the part of O/o CCA Karnataka Circle thereby implying that the delay was on the part of BSNL.

4. Therefore, as the Vigilance Clearance was issued by Corporate office and thereafter the O/o CCA Karnataka Circle has made the payment of Gratuity on 22-10-2020, the matter may be examined by Corporate office and a reply arranged to be furnished to the Letter No. AIBSNLREA/CHQ/2024/13 dated 19-2-2024 from Shri RR Balasubramanian , General Secretary of All India BSNL Retired Executives Association with copy to this office .
