2. I have had the matter looked into. It has been observed the case was ratified by us on 15th May, 2015 for further necessary action by BSNL and CMD, BSNL has informed that after receipt of ratification from this Department on 15.05.2015, the CGMT Jharkhand has issued the final order. Shri B. Mistry, retired on 30.05.2015. He has also informed that a charge sheet is pending for trial in the CBI Court (RC 13(A)/2006-R) due to which his vigilance clearance is still withheld till finalization of the court case.
