The undersigned is directed to say that Pensioners Portal was launched as a Mission Mode Project of the Department of Pension & Pensioners' Welfare (DoPPW) under the National e- Governance Plan (NeGP) in March, 2007 for its implementation during the 11th Plan Period (2007- 2012) and was extended thereafter till 2026 for its continued implementation.
