Ours is an association of Retired BSNL Executives, registered under Pensioners Portal. We participated in the interactive meeting Secretary (Pension) had with registered pensioners associations, virtually on 21.3.2024.

We are submitting herewith a representation addressed to the Secretary (Pension), copy marked to Joint Secretary (Pension), regarding the pathetic situation a pensioner is in, due to deduction of huge amount of penalty by Income Tax department from the refund due to him, because of failure of BSNL authorities to pay the TDS recovered from his salary while he was in service, to the IT department. BSNL authorities refuse to acknowledge the enormity of the issue and are simply pushing the ball around, saying the data is not available with them, in spite of the pensioner submitting copy of Form 16 and Form 26AS for the period.
