

With reference to the grievance and subject mentioned above, it is intimated that as per DE (Admin) Dhanbad, a clarification was asked from C.O. Ranchi for DCRG payment of Sri Prem Shankar Prasad as vigilance clearance is withheld due to CBI Case No RC-4(A)/2000(D) pending against him. In reply, vide letter no ST/Revision Pension/SSA-Unit/JKD-2011/92 Dated 05.04.2021, C.O. Ranchi intimated that since judicial proceedings are still pending against him, so as per GOI decision under Rule 68 of CCS Pension Rules, 1972, as well as under the provision of Rule 69(i)(c) of CCS (Pension) Rules, 1972, DCRG cannot be released until the conclusion of the judicial proceeding and the issue of the final order thereon.


