# Points raised by Pensioners' Welfare Associations during meeting held on 21.03.2024

1.	Bharat Pensioners' Samaj, New Delhi	i)Merger of CCS 2021 Rules with Railway Pension Rules  ii)Department wise information of Government employees retiring in next six months to enable the Associations to increase pensioner base and assist them.	
2.	The Karnataka Central Govt. Pensioners' Association, Bangalore	i) Grant-In-Aid is not sufficient and should be increased. ii) Number of doctors should be increased at Wellness centres to enable timely consultation of CGHS senior citizen patients. iii) A number of problems are faced by SPARSH pensioners which need to be attended to by an appropriate cell.	
3.	Central Government Pensioners' Association, Jaipur	One has to visit Wellness centres for referral each time, some test is advised by CGHS hospitals. A software may be developed by CGHS for online approvals/medicines on the same lines as the RGHS of Rajasthan Government.	
4.	The Disabled War Veterans, New Delhi	Complaints lodged on SPARSH are not replied and the same needs to be monitored by a central body.	
5.	Central Government Pensioners' Welfare Association, Regd., Ambarnath	There are many cases where pensions have been stopped despite submission of DLC. It could be because of entry of old PPO numbers. This needs to be streamlined. It also appears that Aadhar numbers have not been linked in SPARSH.	
6.	Karnataka Posts and Telecommunications' Pensioners' Association, Bangalore	i)Suggestions given in SCOVA have been implemented and issues addressed to the satisfaction of pensioners. BSNL and DOT pensioners are now receiving SMS giving details of pensions received.  ii) Legal heir certificate is being demanded by Banks from the family pensioners before commencement of pension. Guidelines on this subject with regard to documents required for commencement of family pension should be re-iterated.	
7.	All India Oganisation of Pensioners (Civil & Military), Thiruvananthapuram	i)Holding of LAC meetings during OPD hours is a cause of delay and discomfort for patients and the same should be conducted outside OPD hours. ii) There are limited empanelled hospitals at Kerala. If feasible CGHS pensioners may be permitted to avail consultation at ECHS.	
3.	on, Chennai	i)System for online referral may be started by CGHS as patients have to came back to Wellness centres several times for referrals after consulting at CGHS hospitals.  ii) In case of CGHS pensioners there is a grace period of three months between retirement and issuance of new CGHS card. This facility should also be provided to BSNL pensioners.	
	3	i)MOD has revised disability pensioners but the same has not been revised for civilians and it is required that this disparity be removed.	

		ii) A separate meeting should be convened with SPARSH and CDA Allahabad to resolve issues of Defence pensioners as presently there are a lot issues in the data transferred from Banks to SPARSH.
10.	Railways Sr. Citizens Welfare Society, Mohali	DLCs have been very beneficial. However, there are major problem being faced in registering of DLCs with Banks leading to stoppage of pension in several cases. This needs to be resolved proactively by taking up with Banks for synchronization of PPO numbers.
