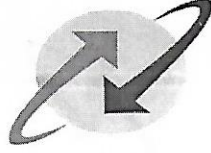

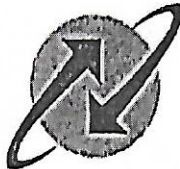


**Sub: Condoning the administrative delay in between completion of pre-appointment training and regular appointment for counting training period for pensionary benefits of Sh. Ajay Kumar Dubey, Ex-AGM retired on 31.01.2020 under BSNL VRS -2019.**

With reference to your office letter no. उ.प्र.(प.)/प्रशा.-69-20/सेवानिवृत्त कर्मचारी शिकायत/2018/35 दिनांक: 25.02.2021 on above cited subject, it is to intimate that this office order dated 08.01.2020 regarding condoning the administrative delay in between completion of pre-appointment training and regular appointment for counting training period for pensionary benefits in respect of Sh Ajay Kumar Dubey, Ex-AGM was issued in accordance to the provisions mentioned in GoI decision (3) under Rule-22 of CCS (Pension) Rules 1972.

However, on reviewing BSNL Corporate Office letter no. 1-15/2019-PAT(BSNL)-Part dated 26.11.2019 regarding FAQs of BSNL VRS-2019, it was found that pre-appointment training is counted as qualifying period for pension in respect of only BSNL absorbed officials, who fulfils the conditions as stipulated in GoI decision (1) under Rule-22 of CCS (Pension) Rules 1972.

It is clarified further that BSNL field units follow the guidelines issued or endorsed by BSNL Corporate office only. Since, no guidelines have been issued by BSNL Corporate Office regarding GoI decision (3), hence the request of Sh Ajay Kumar Dubey can not be accepted.
